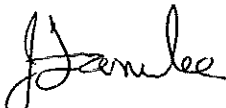

Tudor Rose Bus Shelter

A complaint has been received on a health and safety matter concerning the bus shelter on the A259 opposite Tudor Rose. The metal has rusted due to general wear and tear due to its age. A bus user has emailed regarding the safety of the bus shelter, citing a complaint as the rusted metal caught her dress. This was a scheduled repair, although is now a priority for the Town Council to be completed before the end of May and will go before the next Planning and Highways Committee. The license for the replacement has been received from ESCC Highways and invoice has been received for materials, pending payment. The bus shelter will be replaced as soon as possible, until which time the Eastern side of the bus stop has been cordoned off with barrier tape. This will not affect the use of the seating area inside the bus stop.

Piddinghoe Avenue

The ESCC Highways team are in the process of assessing the use and pollution of this road, in preparation for the speed table installation. We have been informed that speed cameras have now been installed and information will be available within the next few weeks. The dates for speed restriction tables being installed will be informed at future Planning and Highways Committee via the Town Manager.

Neighbourhood Plan

The introduction and initial meeting to commence the Neighbourhood Development Plan in Peacehaven was held on Wednesday 27th April. It was well attended by representatives of local charities and community groups. The Plan itself is a Mammoth task, incorporating issues such as Heritage, Travel and Medical Services to be looked at. A full report will be delivered at the next Full Council Meeting by Councillor Reg Farmiloe.

The toilets in the Meridian Shopping Centre were recently vandalised. Due to the Council toilets being over used by visitors to the shopping centre, we have had to close our toilets to the public during non peak times.

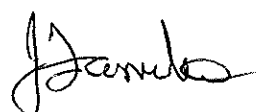

The Peacehaven & Telscombe FC presented a power point presentation high lighting three options:-

- Rent Club House directly to CATS
- Sub-let identified land area
- Release identified area back to Council to enable direct lease agreement

Due to restrictions with regards to alcohol being on the premises and unable to sub-let without permission, the third option was the preferred solution

The CATS Club presented a video highlighting their activities and function, stating they are the largest after school club in East Sussex

A parent stated she was a representative of the 300 plus parents who use CATS Club, confirming they provide crucial support for working parents in Peacehaven

The parent stated that CATS Club support four schools in the area, collecting the children after school

The parent noted that new housing in the area had increased demand for this type of service

The parent noted that CATS Club also provide a holiday club

Cllr. A Harrison questioned the reason behind the invitation to become a member of Leisure & Amenities this year and suggested it was pure mischief

Cllr. J Harrison-Hicks noted that this was Cllr. A Harrison's opinion

Cllr. D Neave stated that Cllr. J Harrison-Hicks was the leader of a political group and not Council and suggested members vote on the motion that Cllr. A Harrison become a member of Planning & Highways

Cllr. D Neave read the following:-

'The simplest way for a Council to select members on to committees is for the Clerk to write to all Councillors and invite them to state their preferences for particular committees. It is usual for a Council to have a measure of restriction built into its Standing Orders that states Councillors may only sit on up to two committees.

When the preferences come in, it is simply a matter of balancing the undersubscribed committees with those that are oversubscribed and 'horse trading' to achieve the right numbers. In some places this is done informally by the Clerk and in others by the Policy Committee. In our sector there is no issue of political proportionality on committees, unlike principal authorities. There is also no such person as a 'senior Councillor' – all councilors are equal irrespective of their length of service.

Whatever procedure is adopted it must be transparent and clearly understood by all.

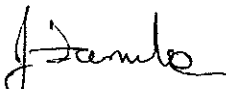
It can only be the Council, not the group meeting, that makes the decision on committee representation. If you do not have a restriction on the number of committees that a Councillor can sit on in your Standing Orders, then the arithmetic of the voting will rule and a minority party of one can find themselves excluded from all committees as 'political balance' does not apply to local councils. Twin hatted District Councillors do not always understand the local Council system as they are used to political balance.'

The committee Chairs and Vice Chairs need to be voted in by member of that committee at Annual Council (with just committee members voting on those items), the Vice Chair was then elected at the first meeting of the newly formed committee.'

C Lacey referred to Standing Orders 9B:-

'No motion may be moved at a meeting unless it is on the agenda and the mover has given written notice of its wording to the Proper Officer of the Council at least 7 clear days before the meeting'

Cllr. D Neave stated this is an agenda item and noted that it is difficult to provide 7 days notice when paperwork is only issued on the Thursday before a meeting

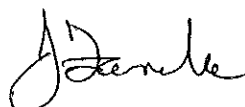

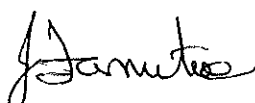
